THE TEWKESBURY BOROUGH COUNCIL (OFF-STREET PARKING PLACES) ORDER 2015

<u>NOTICE</u> is hereby given that on the Twenty-sixth day of March 2015 Tewkesbury Borough Council in exercise of its powers under Sections 32, 33, 35 and 124 and paragraph 27 of Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act of 1984") and in exercise of all other powers it enabling in that behalf and after consultation with the Chief Officer of Police in accordance with paragraph 20 of Part III of Schedule 9 of the Act of 1984 made the above named Order

The Order relates to the Council's car parks within Tewkesbury at Gloucester Road, Oldbury Road, Railsmeadow, Spring Gardens, St Mary's Lane, Station Road, The Vineyards and Bishops Walk, its car parks at Back Lane and Bull Lane, Winchcombe, Pipers Grove, Snowshill, Chapel Hay, Churchdown and at Church Road, Bishops Cleeve.

The effect of the Order will be:-

1. To vary the parking charges at the car parks situated at Gloucester Road, Oldbury Road, Railsmeadow, Spring Gardens, St. Mary's Lane, The Vineyards and Bishops Walk, Tewkesbury and at Bull Lane, Winchcombe. The proposed charges will be as follows:

Up to I hour	£1.00	
Up to 3 hours	£2.00	
Over 3 hours	£4.00	

2. To reduce the Standard Permit Charges in respect of the following car parks:

Bishops Walk, Spring Gardens and Bull Lane		£500.00
Station Road		£150.00

- 3. To enable permits to be purchased which will permit vehicles to park without payment of parking ticket charges between the hours of 3.30 p.m. and 5.30 p.m. on each day in the car parks situated at Gloucester Road, Railsmeadow, Spring Gardens, St. Mary's Lane, Station Road, The Vineyards and Bishops Walk, Tewkesbury and at Back Lane and Bull Lane, Winchcombe. The annual cost of these permits will be £26.00.
- 4. To introduce facilities to enable the payment of parking charges, other than permit charges, by means of mobile phone or text message.
- 5. To enable parking tickets purchased in any car park other than Station Road, Tewkesbury and Back Lane, Winchcombe to be lawfully displayed on the vehicle in respect of which it was purchased on any of the Council's car parks other than at Station Road, Tewkesbury and Back Lane, Winchcombe.
- 6. To enable any parking ticket purchased after 5.30p.m. on any day to be lawfully displayed on the vehicle in respect of which it was purchased on the day following the date of purchase provided that the period of time for which the ticket was purchased will be considered as having commenced at 8.00 a.m. on that following day.
- 7. The Tewkesbury Borough Council (Off-Street Parking Places) Order 2009 will be revoked but the provisions of that Order will be continued in force except as varied as

described in paragraphs numbered 1 to 6 (inclusive) of this notice by the virtue of this Order.

This Order which comes into effect on the First day of April 2015 may be examined at the undermentioned address on Mondays to Thursdays between 9.30 a.m and 5.00 p.m. and on Fridays between 9.00 a.m. and 4.00 p.m. Any person wishing to question the validity of this Order or any provision contained in it on the ground that it is not within the powers conferred by the Act of 1984 or on the ground that any requirement of the Act of 1984 or any instrument made thereunder has not been complied with in relation to this Order may within six weeks from the Twenty-sixth day of March 2015 make application to the High Court.
